This week we signed documents from the Federal Government regarding funding for the 12 bed memory support unit, the next major project for the boards strategic plan.



Installation of solar power and upgraded sprinkler systems across the site continue investment for the future.

All these capital investments will complement the existing components of the community's medical precinct.

Louise and I attended a presentation on Stroke Awareness held in the Diversional Therapy building last week. Great to see a large crowd in attendance and the room being used by visitors and residents. I met with the auditors who are on site working towards our end of financial year close. Auditor Ben confirmed the overall strength of the Clifton Community Health Services and the professionalism of all staff and the dedication of all the volunteers as he and his team moved about the site. With some tough government regulations and policies coming into play for health facilities in general you can be assured your board of directors are developing and implementing strategies to maintain the high standard of health care and services that are currently available.

## **General Manager: Brad Jones**

What an action packed few months it has been.

The ACAR (Aged Care Approval Round) results are in, we were successful with our application and have received approval from the Federal Government for 12 new bed licences for Clifton Nursing Home. We were also successful with our Capital Grant Application which will see the Australian government contribute \$1,500.000 towards

Application which will see the Australian government contribute \$1,500.000 towards the total cost of the project. The project will see us construct a purpose built 12 bed Memory Support Unit to cater for the needs of people within our Rural Community who are living with Dementia.

We have recently appointed Elia Architecture to design the building and will be consulting widely with our staff, volunteers, residents, families and industry experts to deliver a world class outcome.

If you have ideas you would like to share we would love to hear them, please contact me, all input is welcome.

We have also signed the contract for our roof mounted solar system which will reduce our very large electricity bills and allow us to direct more funds into resident and patient care. Installation of this system should begin in June depending on receiving the relevant approvals.

Design of the Full Fire Sprinkler System for the site has had to be altered to allow for the connection of the new unit. June is the new target date to go to tender on this important project.

As Heather has mentioned we will again welcome the Surveyors from ACHS (The Australian Council on HealthCare Standards) for a regular visit in June.

Work is continuing behind the scenes on the S&N pathology collection outlet and substantial progress has been made. I am still hopeful of announcing an opening date shortly.

The last few months have also seen us appoint new Information Technology Providers and new Printer and business machine providers. These strategic appointments will improve on our current infrastructure and position us for the future expansions.

Our new online staff training platform went live in Mid-May and is aimed at enhancing the quality and quantity of training that we can provide to all our team members as well as making training easier to access.

The media in recent times has contained many disturbing stories of violence directed at Health care workers, unfortunately small rural towns are no longer immune to such incidents. To improve safety and security for all team members across all aspects of the business we have appointed an external company to conduct a comprehensive Occupational Violence Risk Assessment and to deliver additional training to all staff.

In August we will have a display at the Seniors Expo in Warwick.
